### 557/22 Adjournment of the meeting

**Issues Raised:** 

Mission House Langrigg: Parishioners raised concerns regarding the change of use for the house without and formal notification being received. Car associated with the building are parking on the roadside causing a narrowing of the road potentially being problematic for larger vehicles to pass. There are concerns of the property not being secure for residents. Cllr M Johnson has offered to engage with the business directly to see if a meeting can be arranged with parishioners to gain more information regarding the operating of the business and provide reassurance for parishioners living in the village.

Red Barn, barn conversion: Concerns over new plans submitted on the 28<sup>th</sup> July 2022. The driveway has been widened further than previous planning submission. The landscaped area has changed from 3.4 meters to 1 meter. New plans also leave a 12mm gap with the neighboring house. The red boundary line has been moved forward towards the road.

Cllr Johnson reported on the Local Government Reorganisation: The reorganisation is progressing well, from the 1<sup>st</sup> April 2023 Allerdale Borough Council and Cumbria County Council will be non-existent.
